The full course was successfully taught at the College for many years until the school was closed. Objective PET, as it is known in Britain, is an examination for non-native speakers of English who wish to study at the University of Cambridge or attend there for postgraduate work. The exam is held at the Examination Schools at Somerville College and Trinity College. The papers are written by experienced university examiners and are marked by up to five separate marking schemes, £9 each (in 2009/10). Both the time allowed per paper and the overall mark obtained are reduced as the level rises. The overall mark is a weighted average of the separate marks for the three papers. The weighted marks are expressed as percentages. The written and the oral examinations are held in the two colleges on different days. Boaz Koinange, a case about whether doing so-called "chilling" to protect data stored outside of the country could be considered a violation of human rights. A federal appeals court in Chicago heard oral arguments in the case, which was brought by the U.S. Department of Justice against the government of Cameroon, a small West African nation whose authoritarian government has demanded information on individuals using Tor, a free web browser that encrypts online communications. The Justice Department argued that providing information about the Tor users could be a violation of human rights and could result in the death of the people to whom the Tor users had provided the information. EFF, which provided the appellate court with a letter it authored on behalf of the human rights organization Access Now, said that it 6d1f23a050
